AND UPON the Plaintiff giving the appropriate undertakings as required by the Court

AND UPON hearing counsel for the Plaintiff

 This is an injunction made against the First to Seventh Defendants, on 16th February 2024 by the Honourable Chief Justice Ramsey-Hale on the application of the Plaintiff.

IT IS ORDERED THAT:

- 2. The First to Seventh Defendants are restrained from holding themselves out to be directors of the Company and from taking any steps to exercise any powers as though they were directors.
- 3. The First to Seventh Defendants are restrained from issuing any press release or filing any document with the SEC or any other government body either in the Cayman Islands or elsewhere which asserts that (i) the Defendants are directors of the Plaintiff and/or (ii) that the Defendants have been appointed pursuant to a validly constituted EGM.
- 4. The First to Seventh Defendants are restrained from taking any steps authority for which is purportedly derived from any director resolution or other decision taken by them purportedly acting in the capacity of a director or holding out that any such resolution has been properly passed or any decision has been validly taken.

Duration of this Order

5. Paragraphs 2 to 4 of this Order will remain in force until the conclusion of a hearing to be listed on Wednesday 21 February 2024 before the Honourable Chief Justice or any further Order of this Court varying or discharging this Order in the interim.

Variation or discharge of this Order

6. The First to Seventh Defendants (or anyone notified of this Order) may apply to the Court at any time to vary or discharge this Order (or so much of it as affects that person), but anyone wishing to do so must first inform the Plaintiff's attorney in writing on not less than three days' notice.

Undertakings

7. The Plaintiff gives to the Court the undertakings set out in Schedule 1 to this Order.

Third parties

- 8. It is a contempt of court for any person notified of this Order knowingly to assist in or permit a breach of the Order. Any person doing so may be sent to prison, fined, or have his assets seized.
- 9. Except as provided in paragraph 10 below, the terms of this order do not affect or concern anyone outside the jurisdiction of this court.
- 10. The terms of this Order will affect the following persons in a country or state outside the jurisdiction of this Court:
- (a) Any person who:
 - (i) is subject to the jurisdiction of this Court;
 - (ii) has been given written notice of this order at his residence or place of business within the jurisdiction of this court; and
 - (iii) is able to prevent acts or omissions outside the jurisdiction of this Court which constitute or assist in a breach of the terms of this order; and
- (b) Any other person, only to the extent that this order is declared enforceable by or is enforced by a court in that country or state.
